Note: This Company was registered in England on 5 November 1863 as the Australian, Mortgage, Land & Finance Co. Ltd. The name was changed to its present form in November 1910. The Company has carried on business as wool brokers, merchandise, stock and property agents and as a pastoral company in New South Wales, Victoria and Queensland. By 1970 the Company had been taken over by Wood Hall Trust Ltd in the U.K. although the Australian company has continued to carry on business without any change of title. The Australian head office is now located in Sydney, N.S.W.
